The Laredo Independent School District and all its schools will continue its policy to operate the Community Eligibility Provision (CEP) under the National School Lunch Program and School Breakfast Program for the 2020-2021 school year. Schools qualifying to operate CEP serve breakfast and lunch to all children at no charge and eliminate the collection of meal applications for free, reduced-price, and paid student meals. This new approach reduces burdens for both families and school administrators and helps ensure that students receive nutritious and balanced meals that meet the USDA meal pattern guidelines.
